Employee and Wage Data for NCC Graduates – 2014-15 – 2016-17


This report is a product of the P20WIN project, a data sharing agreement between CT's Department of Labor and CT's public higher education institutions. This report focuses on NCC graduates two years after their award, showing the number employed in CT and their annual wages at that point in time.

KEY FINDINGS:

- 1. Two years after graduation, 62% of NCC Grads were employed in CT.
- 2. Two years after graduation, the median annual wage for NCC graduates is about \$37,233
- 3. Several program areas have graduates with median annual wages over \$50,000 including Nursing, Digital Media Design, Health Professions and Respiratory care.
- 4. Median annual wages are likely under-stated vs. the full-time employment market since they include graduates working part-time and/or pursuing further education along with graduates working full-time. Employment rates do not count self-employed nor out-of-Connecticut as employed.



Caveats about this data

• Only data for individuals employed in CT are included; self-employed individuals are excluded; No adjustments are made to reflect full time vs. part time employment nor higher education enrollment.

• Wage and employment data are provided by CIP code for NCC graduates in academic programs with that CIP code. DOL data is aggregated at two- and six-digit CIP levels, not by NCC program.

• An estimated annualized wage is provided for the second year after individuals complete a credential. Wages are included for individuals who meet the definition of 'Stable' employment for Post Q8 after graduation. These quarterly wages (Q8 Post-Grad) are multiplied by 4 to get an annualized value. Reasoning: This is a more accurate estimate of annual wages than counting actual wages earned over 4 quarters which will just compound errors inherent with a cohort that includes part-time and full-time employment.

• The 'stable' approach counts individuals as employed and uses their wages in calculations if they were employed in the quarter of interest (t), in the quarter prior to (t-1) and also in the quarter after the quarter of interest (t+1). The definition of stable employment developed by for the US Census was modified slightly here to account for normal employment patterns prior to when individuals begin their education program and immediately after completion.

• While additional cohorts are available, most of this report focuses on 2014-15 thru 2016-17 because later cohorts have a dramatically smaller percentage of graduates qualify as stable employed.

• NCC TOTAL* represents the count for programs with valid and not suppressed data – results in exclusion of a small number of NCC Grads.

EMPLOYMENT AND WAGES BY NCC PROGRAMS

In the tables below, the columns are:

1. Classification of Instructional Programs (CIP) code of the aggregated data shown in that row

2. NCC academic program, listed within their assigned CIP codes (Classification of Instructional Programs); programs with the same CIP codes are grouped together

3. Total Grad Count - NCC graduates in the NCC programs with that CIP (grads in 2014-15, 2015-16, 2016-17)

4. % Employed Post Q8 - Share of graduates employed in CT at Q8, or in the quarter two years after graduation

5. Stable Employed Post Q8 - Count of NCC graduates in stable employment at Q8 – defined as CT wages

in Qs 7-8-9 after graduation; these are the graduates that account for the Median Wages column

6. % Employed Post Q8 - Share of graduates in stable employment at Q8 post-graduation

7. Annual Median Wages - calculated from Q8 post-graduation among those in stable employment
