JOB SUMMARY:

Performs a variety of non-invasive diagnostic cardiology procedures on both an inpatient and outpatient basis. Processes all Cardiology charges for these exams and prepares exams for physician interpretation and final transcription and reporting.

MAJOR ACCOUNTABILITIES/CRITICAL RESPONSIBILITIES:

- 1. Performs EKG's on patients with a high degree of reliability as to tracing quality and lead placement. Explains the exam to patients and exhibits confidence as to ability and competence in performing the exam. Reports grossly abnormal findings to a Physician or Nurse immediately when observed. Responds to inpatient orders in a timely fashion.**
- 2. Performs Exercise Tolerance Tests, both nuclear and non-nuclear in conjunction with a provider. Exhibits understanding of the procedures and prepares patients carefully while insuring their comfort and safety.**
- 3. Performs 24 Hour EKG and BP monitoring application and analysis. Explains the equipment and procedure to patients before application to insure a valid study is obtained.**
- 4. Processes charges through the computer system and prepares all exams so they are ready for physician interpretation in a timely manner.**
- 5. Schedules patients for exams with physician offices and inpatient units being careful to obtain all needed information and explain any patient preparation needed for the particular tests.**
- 6. Maintains EKG, Stress, and 24 Hour monitoring equipment in a clean and safe manner.**
