### **GENERAL JOB SUMMARY:**

Coordinate and deliver patient care utilizing the direction of licensed nursing personnel and following all established standards of practice within State and Federal guidelines. Act as preceptor to new staff and/or students as requested. Adhere to all Stamford Hospital's policies and procedures, including the Code of Conduct and Corporate Compliance Program. Provide safe and therapeutic care using the values inherent in our hospital culture.

## CORE COMPETENCIES/CRITICAL RESPONSIBILITIES:

### A. Clinical Excellence

- a. Provides direct patient care to a select group of patients and advocates on their behalf. Includes:
  - i. Bathing, dressing, undressing, bed pans, urinals,( toileting), mouth care/grooming and shaving as directed by licensed nurse
  - ii. Taking vitals and intake and output, as directed (Blood glucose monitoring, EKG)
  - iii. Collecting food trays, providing water pitchers and feeding as guided by licensed nurse
  - iv. Changing room linens and tidiness of room
  - v. Directing visitors as needed
  - vi. Constant observation &/or remote video monitoring as needed
  - vii. Assisting with transferring patient with ambulation, turning and positioning & chair
  - viii. Assists with adjunct therapies such as enemas, heat packs, ice packs, sitz baths as directed.
  - ix. Phlebotomy as directed and to policy.
- b. Assists with assessment of patient's physical and psychosocial condition with reports to licensed nurse.
- c. Supports and promotes hospital-wide and unit specific initiatives & goals (e.g. Planetree, Magnet, hourly rounding etc.)
- d. Practices and promotes patient safety and quality of care with continual communication with licensed nurse.
- e. Documents pertinent information, observations and all aspects of patient care clearly, concisely and in a timely manner.
- f. Assists with education process for patients and families.
- g. Adheres to hospital and department specific dress code policy.

**a.** Respects and protects the patient's rights to confidentiality and privacy and discloses information only for professional purposes with collaboration of licensed nurse.

  - b. Keeps all unit caregivers informed of issues and policies that affect patient care or nursing practices by actively participating in the shared governance.

  - d. A clear direction and collaborates responsibility when appropriate.
  - e. Performs duties as assigned or requested in order to maintain a high level of service.

# MANUAL SKILLS:

Significant portions of daily assignments involve application of manual skills requiring motor coordination in combination with finger dexterity (eg typing, equipment operation, administration of nursing care).

## **PHYSICAL EFFORT:**

Mobility is necessary to provide patient care. Physical effort is required to assist patients with transfer and ambulation, which may involve lifting, pushing and pulling patients. Hearing within normal range is necessary in order to properly conduct assessments. Must be able to endure prolonged periods of standing and walking.

# **PHYSICAL ENVIRONMENT:**

Regular exposure to blood/body fluids, chemicals and equipment used in the treatment of patients. Significant portions of daily assignments involve occupational risks such as cuts, needle puncture, exposure to toxic chemicals, injuries from falls or back injury sustained while assisting with moving, lifting or positioning patients, equipment or materials. May be required to manage the care of patients during altered states of consciousness and to perform physically demanding patient care.
